

CEL PRIVACY POLICY

Effective: May 1, 2022

Citizens Education, Inc. (CEI) values its users' privacy. This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. CEI may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from chs.bestfuturefinder.com and its subsidiaries.

CEI and its subsidiaries may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

· as necessary to maintain, safeguard and preserve all the rights and property of CEI.
